1. Call to Order

-Meeting called to order: 19:01pm -Members present: Mark Rowe; Brett Funderburg; Tim Miller; Chris Burke; Cheng Wooster; Jetti Nasrallah; (Russell Jakala not present)

Review of Last Board Meeting Minutes - 8/30/2016
 -Motion to approve as presented; passed

3. Amenity Center Bathroom Renovations

-Engaged architectural review to re-design bathroom and washroom facilities for year-round access. -Compared against the Reserve Study and 3-year projection for budget constraints

-Preliminary estimate ~\$600,000; Includes 13% Architect fee (Barley|PfeifferArchitecture) and 10% over-cost buffer.

-Construction could begin Fall 2017; 6-months build-out; weather permitting

-Could be covered by \$100 Special assessment; semi-annual \$50 payments

-Motion was made, seconded, and carried. Board approves going forward engaging the Architects with Construction Documents

-Funds could be provided with \$400,000 over two years from general funds and \$200,000 from special assessments)

-Budgeted in 2017 : \$200,000 for construction, \$50,000 architects fees.

4. 2017 Budget

-Landscape budget combined Tree Trimming and Irrigation into new Landscape Contract, to save on annual cost (saving \$15000 annually) and improve communication. Tree trimming now included with landscaping.

-Landscaping and Irrigation services now provided by PerfectCuts.

-Water budget continues to increase. Experimenting with smart-sensors and wireless control. Pilot program on a single meter with 3 controllers to evaluate savings.

-Pool shade canopy repair (damaged by vandalism) in the budget; Defer replacement for early Spring.

-Asphalt resurfacing and Retaining Walls, masonry repair moved to 2018 budget.

-Motion to approve budget (Strike lines 50,51); seconded and carried. -Amended Motion to move assessment increase and special assessment approval to the Annual Meeting

5. 2016 Annual Meeting

-Annual Meeting date set for February 7, 2017 at 7pm; subject to the availability for the main auditorium of the church. February 8th is the backup date; -Annual Meeting will discuss assessments increase or; re-evaluate need for special assessment.

6. Mark Weaver; Representing Canyon Creek working with City of Austin

-Crossland & Boulder re-paving by City of Austin

-Street light repairs are PEC, not City of Austin

-Working to get asphalt patch repair for cracks in CYC sidewalks

-Advised on home-owner concerns for street parking and boat-storage along Boulder Lane.
-Vehicles over 9000 lbs can not be parked on residential streets; Roads with speed-limits over
30mph are not residential streets; Boulder Lane is currently 35mph speed limit.
-Options include No-parking limit signs posted for School-bus parking; Reduce speed-limits back to
30 mph; stripe bike-lanes along Boulder.
