POOL PARTY POLICY & REQUEST FORM

FIRST COME, FIRST SERVE on dates and times.

NO pool parties will be scheduled for the same time or on the following days:

**Easter, Mother's Day, Memorial Day, Father's Day,
Fourth of July, National Night Out and Labor Day**

Informal/Non- Private parties at the pool may be held Tuesday through Sunday between the hours of 11:00 a.m. and 8:00 p.m. (holidays excluded). Monday between 2:00pm to 8:00 pm

BEFORE:

- One party per household is allowed per year.
- Parties may only be scheduled by a Canyon Creek Homeowners Association member over the age of eighteen (18).
- **Limit of 40** party members (kids and adults).
- The party must be scheduled at least two weeks in advance
- The expense is a rental fee of \$25.00 per hour, per lifeguard with a two-hour minimum charge during normal lifeguarded hours; see pool party fee chart below for clarification). **During Lifeguarded Season**

Party Lifeguard is in addition to regularly scheduled lifeguards on duty.

Before and After Lifeguarded Season

Lifeguard Service is for party time block only; no regularly scheduled lifeguards are on duty

Up to 40	2	\$100.00	\$50.00

- The fee must be paid by the party sponsor/member at time of reservation.
- The sponsoring member will be responsible for any damages caused by party patrons and a Recreational Use Agreement may be requested at the discretion of the Board, Spectrum Association Management or Pool Committee member(s).
- The fee includes the ability to bring additional invited guests to the pool during a specified time in which lifeguards have been required to service your function. The fee covers the services of the additional lifeguard(s) during your function and resources to accommodate the additional use of the pool by your invited guests. For the safety of all patrons, members and non-members, two lifeguards must be present at all times during a pool party.
- If your party has 10 or more guests, ask them to bring lawn chairs so that pool chairs and loungers are available for residents.
- Submit this signed form and fees required above made payable to **Canyon Creek HOA to: Spectrum Association Management, Suite 105, 4411 South IH-35, Georgetown, Texas 78626**. Forms are to be submitted **at least two weeks before the party**. If you have any questions, you may email contact@spectrumAM.com.

DURING:

- **DO NOT PROP OPEN THE GATE.** This is a serious safety issue. Assign someone the job of running the key to the gate or sitting near the gate until all guests and supplies have arrived.
- The Canyon Creek Member making reservation must be present during the party.
- No glass of any kind.
- No smoking.
- No alcohol.
- Your party should not inconvenience residents of Canyon Creek who are at the pool. Please be as considerate as possible.
- **Have a great time!**

AFTER:

- **All trash must be taken home and disposed of in your home trash.**
- Take down all decorations.
- Please leave chairs and tables neatly under the awning and rearrange furniture around the pool.
- Wash down your party area with the hose, making sure to wash the food particles toward the grass.
